The University, with the approval of the Executive Council at its 127th meeting held on 27-02-2013, extended the benefit of awarding Minimum Basic Pay of Time Scale, as applicable to the respective category, in RSP 2010 together with allowances viz., DA, HRA and CCA with effect from 01-02-2010 to the Time Scale Employees working in the University, in terms of G.O. 1st cited and University Orders 2nd cited.

2. The Government through G.O. 4th cited, extended the benefit of Revised Pay Scales 2015 and Special Pays & Other allowances to the Regular Non-Teaching Staff of the Universities, with effect from 01-07-2013 notionally and with monetary benefit from 02-06-2014.

3. The Osmania University Time Scale Employees Committee represented to the University to extend the benefit of 10th PRC(Revised Pay Scales 2015) to them also as was done earlier. Therefore, a note was placed before the Executive Council for its consideration.

4. The Executive Council at its 138th meeting held on 22-08-2015 resolved to refer the proposal to the Government for extending the benefit of Revised Pay Scales 2015 in terms of G.O. 4th cited to the Time Scale Employees working in the University, with effect from 02-06-2014. Accordingly, the University through Letters 5th and 6th cited, requested the Government to extend the RSP 2015 to the Time Scale Employees also w.e.f 02-06-2014 on par with the regular employees of the University.

5. The Government through G.O. 7th cited, have permitted the University to extend the benefit of minimum Basic Pay and applicable allowances of Revised Pay Scales – 2015 to the respective categories of Time Scale Employees working in the University, as was done in the Revised Pay Scales – 2010, with prospective effect only, i.e. w.e.f.01/02/2017, subject to meeting the expenditure from the internal resources of the University.

6. In view of the above, the Vice-Chancellor in anticipation of approval of the Executive Council, has accorded approval for extending the benefit of minimum basic pay of the Time Scale, as applicable to the respective categories, in RPS 2015 together with allowances viz., D.A., H.R.A and C.C.A. to Time Scale Employees working in the University with effect from 01/02/2017, in accordance with G.O. 7th cited.
7. The expenditure on this score shall be charged to the respective provisions, from which the Time-Scale employees are presently drawing their Salaries.
8. The Drawing / Disbursing Officer concerned shall ensure that these orders are brought to the notice of the Time Scale Employees working under their control and arrange for Fixation at the Minimum Basic pay of the Time Scale in RSP 2015, as applicable to the respective categories shown in the list appended to these Orders.
9. The Deputy Registrar (Pre-Audit), OU, shall admit the claims accordingly.
