- 1. The Firms should submit their tenders duly enclosing two separate Demand Drafts towards Non-refundable application cost of Rs. 5,000/- (Rupees five thousand only) and EMD for a sum of Rs. 1,00,000/- (Rupees One lakh only) in the name of Registrar, Osmania University, Hyderabad, after going through the conditions laid down.
- 2. Only authorized and certified vendors who are empanelled with GHMC with expertise in the field of erection/installation of signages are permitted to quote against the requirements. The vendors are advised to quote the prices plus taxes as applicable as per government norms.
- 3. The discretion is vested with the University to decide as per the requirements. However, the University shall invite the L-1 bidders for negotiations, if it feels the lowest prices quoted are on the higher side.
- 4. The firm should have a strong base and may give reference of their standing and orders for supply/erection/installation of signages in any Government, Educational Institutions, Municipalities and Public Sectors undertakings for the value not less than Rs.1.00 crore in any one financial year during the past three financial years i.e., 2014-2015 to 2016-17.
- 5. The Bidder shall strictly adhere to all the terms and conditions stipulated by the GHMC, Hyderabad, Government of Telangana with regard to signages tender.
- 6. The bidder shall submit a Test report from internationally reputed laboratories for 36 months outdoor weathering of the retro reflective sheeting and testing of the product for condition as per ASTM Testing requirements.
- 7. The contractor shall, subject to the provision of the contract and with due care and diligence, execute and maintain the works in accordance with specifications and drawings stipulated as per the GHMC norms.
- 8. Security requirements for the work shall be in accordance with the GHMC's general requirements including provisions of this clause and the Contractor shall conform to such requirements and shall be held responsible for the actions of all his staff, employees and the staff and employees of his sub-contractors.
- 9. They shall provide approved OEM converter certificate from reputed sheeting manufacturer and the same shall be submitted along with the bid.
- 10. The Tenderer should be registered contractor of GHMC in Telangana State and a relevant certificate issued by the competent authority should be furnished.

- 13. The offers must be in English. The rates should be indicated both in figures and in words against each item exclusive of taxes as applicable.
- 14. The rates shall be fixed and constant throughout the entire period of the Contract and will not be modified under any circumstances.
- 15. Offers received after the bid closing date/time shall not be considered.
- 16. Telex/Tele fax/E-Mail Tenders will not be accepted and the University takes no responsibility for delay/loss or non-receipt of tenders by post/couriers.
- 17. Any offer containing incorrect statement and incomplete information will be summarily rejected and no unsolicited correspondence shall be entertained.
- 18. PRICE BID of only those bidders shall be opened who qualify in the technical evaluation.
- 19. Osmania University reserves the right to accept /reject any offer in full or in part or accept any offer other than the lowest without assigning any reasons thereof.
- 20. All disputes or differences whatsoever arising between the parties relating to the contract shall be settled by the arbitration in accordance with the rules of arbitration of Indian Council of Arbitration and the Award made in pursuance thereof shall be binding on the parties. The venue of arbitration shall be Hyderabad, and the Vice-Chancellor, Osmania University, Hyderabad 500007, will make the appointment of the arbitrator on behalf of the University.
- 21. The Tenders of those manufacturers/authorized and certified vendors shall only be accepted, who have remitted the prescribed non-refundable Tender Application fee of Rs. 5,000/- through Demand Draft drawn in favour of Registrar, Osmania University.

- 22. The E.M.D of the unsuccessful tenderers will be refunded without any interest.
- 23. The firm must have valid TSGST/CST/CGST Registration Certificate. (Please attach copies of valid certificates).
- 24. The security deposit shall be liable to be forfeited wholly or partly at the sole discretion of the University, if the tenderer either fails to execute the work as per the tender terms, or fails to fulfill the contractual obligations or fails to settle in full his dues to the O.U.
- 25. In case of premature termination of the contract, the Security Deposit will be forfeited and the O.U. will be at liberty to recover the loss suffered by it & if additional cost is to be paid, the same shall be recovered from the tenderer.
